Sign up on/before April 30:

Safety & Mandatory Equipment Requirements

After your child's first season in karate, they will advance to The Black Belt Club where they will be required to have Sparring/Protective Gear. At The Dojo American Karate Centers, we go to great lengths to make karate as safe as possible. We have invested heavily in floors that absorb shock to the joints and cushion the spine.

In addition, we make sure all our training with a practice partner is as safe as possible by using the latest in martial arts safety gear. This allows a student to practice the techniques with realistic speed and power while at the same time keeping the risk of injury to a minimum. This level of intensity while practicing is necessary in developing the greatest level of confidence and familiarity in the technique.

The following lists the required equipment for each course level to practice as described and take advantage of the training with the lowest risk of injury.

For reasons of safety, liability insurance requirements and system-wide uniform dress requirements, all equipment MUST be approved The Dojo American Karate Center logo gear.

Policies & Procedures

Snacks: It is suggested that each child bring a healthy snack each day.

Karate Classes: Students will participate in a curriculum karate class Monday- Thursday. We will have non-curriculum training and conditioning on Fridays.

Pick Up: All scheduled activities will end at 5:00 P.M. each day. Pick up until 5:45 P.M.

Discipline Policy

Please read this discipline (behavior) policy and acknowledge your agreement with the terms by initialing below.

In the effort to provide your child and other students with a safe and fun experience, it is necessary that all students exhibit proper behavior, self-discipline and self-control. Correcting unsatisfactory behavior is time consuming and distracts from providing quality, safe, educational, and fun activities for the rest of the students.

If we are unable to control a situation we will contact the parents first by telephone at or near the disturbance, so that the parent may reinforce (by phone) the requirement that all students enrolled at the Dojo After School Karate program behave satisfactory and follow instructions fully and promptly.

Students that cannot be controlled by verbal commands or that are a constant disciplinary problem will be suspended from the program(s).



General Waiver & Medical Release

I (Parent OR Guardian) give my consent to The Dojo American Karate Centers, its officers, agents, employees, individuals associated with the organization or any emergency medical personnel to administer necessary treatment to my child name above in the event of an emergency and authorize transportation for my child by ambulance if situation warrants.

I (Parent OR Guardian) give my consent to The Dojo American Karate Centers, its officers, agents, employees, individuals associated with the organization to transport my child to and from The Dojo and authorized activities and events.

- 1. WAIVER & RELEASE:** Buyer(s) understands that Student(s) is engaging in physical activity/exercise, along with the use of The Dojo's facility, equipment, training and instruction, which can be dangerous & could cause injury. Therefore Buyer(s), assumes all risk of injuries to said individual(s). Buyer/Student(s) hereby waives and releases any claim or right to sue The Dojo, employees or agents for injury. Buyer(s) has carefully read this waiver & release and fully understands that it releases The Dojo of all liabilities for any injury that may occur. It is always advisable to consult your physician before undertaking any physical activity/exercise program, particularly karate activities.
- 2. LOSS/DAMAGE/THEFT:** The Dojo does not assume any responsibility for the loss, damage or theft of any property belonging to the Buyer(s)/Student(s) and agrees that The Dojo and its personnel are not responsible or liable for any such property in the event of loss, damage, or theft on or about the facility.
- 3. NON-COMPETE:** It is prohibited for any Student and/or guest(s) to conduct any commercial business or activity, or solicit any business competitive with that of The Dojo (including personal training services), from or about The Dojo premises without prior, express, written consent of owners. The Dojo has the right to recover any revenues received by Student and/or guest(s) in violation of this policy, as well as attorney's fees, court costs, etc. incurred. Student and/or guest(s) may not subscribe to any such business activity.
- 4. I UNDERSTAND THAT THE DOJO IS A MARTIAL ARTS SCHOOL AND NOT A DAYCARE IN AS SUCH, THEIR STOCK-IN-TRADE IS NOT SUPERVISION AND CARE. THE INTENT OF THE DOJO IS TO TEACH MARTIAL ARTS PHYSICAL AND PHILOSOPHICAL CHARACTER BUILDING SKILLS. I UNDERSTAND THAT THE DOJO IS A MARTIAL ARTS SCHOOL AND IS A DROP-IN FACILITY IN AS SUCH; MY CHILD(REN) IS FREE TO COME AND GO. ADDITIONALLY, IF MY CHILD(REN) STAYS AT THE DOJO FACILITY IT IS BECAUSE OF MY DIRECTION AND NOT THE DOJO'S.**

2017/2018 Parent Transportation Responsibility Checklist

I authorize my child to be picked up by The Dojo's A.S.K. designated vehicle and I understand that it is my responsibility to do the following:

- Notify my child's school teacher(s) that he/she will be a Dojo rider.
- Notify the elementary school's office that my child will be a Dojo rider.
- Call The Dojo Studio at 678-947-4076 **BY NOON** if my child will not be picked up on a given day. If your child is not on the Dojo van and you have not called to notify us, we will be calling you to confirm they do not need to be picked up.
- Responsibility for your child boarding The Dojo's A.S.K. vehicle lies solely with the school and / or teachers. The Dojo's responsibility begins when your child boards the designated vehicle.

Student Pick Up Authorization

I understand that only the person(s) I listed on the registration form will be allowed to pick my child up from The Dojo with a valid picture ID. You can update your approved pick-up list at any time in the future.

Monthly ASK Tuition Payments

- All our billing is done **exclusively** in house via automatic Check draft or Credit Card draft. This helps us to collect tuition in a timely manner. We want to be able to spend the most time investing in your children rather than spending time on collections. We will set up your payments to automatically draft on the 1st of each month.
- Your first tuition payment for the month of August, will be due **Monday, August 1st, 2017** (we will run these in house via credit card or check draft).
- Please be aware that your monthly ASK tuition covers any days when we pick your child up from school. Other non-school days such as holidays/breaks, there will be an additional \$35/day charge for day camps if you choose to enroll for them.
- Also, please note, we do not offer prorated tuition during November and December or other school holidays/breaks throughout the school year. Previously there had been a \$30 per day charge for early release days. To compensate for time missed in the above months, we will be providing pick up and care on early release days at no extra charge.
- Your completed registration, registration fee and first payment **are due no later than Monday, AUGUST 1st**. We must have your registration and tuition to maintain your child's enrollment in the After School Program.
